### 15 Description of Product

The equipment is a portable LED head torch powered by three series connected AAA size batteries. The enclosure and lens are constructed from polycarbonate and thermoplastic elastomer compound materials.

There are three models: The 2745Z0, a low power version consisting of three white LEDs; the 2755Z0, a high power version with one white LED, and the 2765Z0, consisting of one high brightness white LED and two low power white LEDs.

The 2755Z0 and 2765Z0 feature LED battery status indicators. All of the LEDs are mounted at the front of the head torch.

The equipment is supplied with head straps which are made from either antistatic elastic polyester, nylon cloth or rubber.

The equipment is designed for use in Zone 0 explosive atmospheres based on intrinsic safety protection concept with an ingress protection rating of IP 54.

- 2. All of the cells must be of the same manufacturer
- 3. Do not replace battery cells when an explosive atmosphere is present. Battery cells must be replaced with the correct polarity.


